Tournaments Rules:

- ~ All prizes and a copy of the final standings will be mailed to all captains by November 30, 2023.
- ~ The tournament will be USBC Certified and all USBC rules shall apply. The 15 pin rule (319e) is waived. All participants must be 2023-2024 USBC members. Non USBC members may compete by paying a \$5.00 USBC participation fee.
- ~ Each participant may enter each event twice. Bowlers may cash once in singles, once in doubles with the same partner, and at least 3 players on the same team must be changed, in order to place more than once in the prize list for team event.
- ~ All Events will be based on the first time you bowl.
- ~ All prize fees shall be returned 100%.
- ~ The prize ratio for singles, doubles and teams will be at least 1:8. For all events it will be at least 1:15.
- ~ **Bowlers will use their highest USBC Certified average with 21 games or more at the end of the 2022-2023 bowling season. If no 2022-2023 average applies, bowlers will use their highest USBC Certified average from previous seasons. If no previous USBC average has ever been obtained bowler may use their highest USBC Certified average with 6 games or more at the time of bowling from 2023-2024 season. All others will be 180 scratch. Failure to use current average shall disqualify score if submitted average is lower than the correct average. Prize winnings shall be based on the submitted average if it is higher than the correct average.**
See USBC Rule 319a.
- ~ If current season average for at least 21 games at the time of bowling exceeds last season's average by 10 or more pins, current season average must be used.
- ~ Bowlers who have qualified for a prize of \$300.00 or more in a tournament in the past 12 months must report to the Tournament Director prior to bowling for possible re-rating. (Rule 319d)
- ~ The estimated prizes for the first place in doubles, singles, team and all events are based on 22 team entries. The tournament is limited to the first 22 teams.
- ~ Entries close November 4, 2023 at 9:00 A.M.
- ~ The Tournament Director shall settle all disputes not covered by USBC rules.
